

Intex International ‘Win a Getaway’ Promotion TERMS AND CONDITIONS.

- 1.** The Intex ‘Win a Getaway’ Promotion 2025 (“Promotion”) is conducted by Intex International Pty Ltd (ABN 95 919 466 212) of 115 McKellar Way, Epping, Vic, Australian 3076 (“**Promotor**”).
- 2.** This competition is NOT available to residents of the Australian Capital Territory (ACT) & Northern Territory (NT)
- 3.** This Competition commences at 12:00am on 10th June 2025 and ends at 11:59pm on 31st July 2025 (AEST) (“**Promotion Period**”).
- 4.** The sections on How to Enter, Draw and Winner Notification, Prizes and Miscellaneous Provisions form part of these Terms and Conditions.
- 5.** This Promotion is only open to Australian customers aged 16 years or older who have not been discovered to have breached these Terms and Conditions.
